Treat patients fairly and in line with the law. Promote equal opportunities for all patients. Listen to patients and give them the information they need, dental supplies uk, in a way they can use, so that they can make decisions. Be trustworthy

Dental treatment under general anaesthesia should only be carried out when it is judged to be the most clinically appropriate method of anaesthesi and only take place in a hospital setting (see the note opposite) that has critical-care facilities.
